### **Proposed Revision**

**GRIP:** The Handle region of the bat must have a grip made of cork, grip tape, or other synthetic material that is permanently attached to the bat. No bare metal, wood or composite material may be exposed in this area. The grip shall not be less than 6" and not more than 15". Resin, pine tar or spray substances are permissible on the Grip region only.

# My reason for the amendment:

This is an outdated rule as any of the attachment grips listed above are not moving or causing any issues that we should be concerned with. If a player has such an attachment on their bat, those attachments will not move on the bat unless intentionally attempted to remove which will take significant work to remove the attachment at all.

[E] JO Fast Pitch with Designated Player (DP) and Flex: with one Extra Player (EP) 11 Players with 10 batting. NOTE: Any player in the line-up can play defense. Any change to the pitcher and/or catcher must be reported to the plate umpire for reasons of the use of a courtesy runner.

# **Proposed Addition**

Subject to the requirements of this rule, any player with a disability, including a diabetic condition, who needs to come out of the ball game while on offense or defense due to the disability, including when batting due to a sugar imbalance caused by diabetes, may have a replacement player substitute for the player until such time as the disability subsides. In order to qualify under this rule, the player with the disability must be disclosed and noted by the player's manager to the umpire at the home plate conference at the outset of play. In the umpire's discretion, the umpire may waive the requirement that the subject player be disclosed at the home plate conference at the outset of play. For purposes of this rule, the term disability shall be defined and construed consistent with the definition of disability in the Americans with Disabilities Act.

### My reason for the amendment:

To be sure the ADA rule gives diabetic persons the ability to sit and rest if they have a low sugar situation and not required a substitution on offense or defense.

The pitcher has five seconds to release the next pitch after receiving the ball or after the umpire indicates "play ball".

#### My reason for the amendment:

The time between pitches is too long and slows down the game. Coaches at the highest levels of Slow Pitch including the Supers, Men's AA, and the Women's Open shared displeasure to Kevin Ryan, Steve Shortland, Rich Cress and the UICs at this year's Championship that the pace of the game is too slow. They recommended the pitcher's time to pitch be shortened from "10" to "5" seconds to instill a consistent pace of play in the game. This rule change will align the USA Softball slow pitch pitching rule with other competing organizations to ensure our coaches and players draw satisfaction playing Slow Pitch with USA Softball.
